CASA of McDonough County Program Update

CASA of McDonough County has begun participating earlier in the life of juvenile abuse and neglect cases. We now attend hearings as early as "shelter care." The "shelter care hearing" takes place following the initial DCFS (Department of Children and Family Service) investigation; the investigator determined the child(ren)'s safety is at risk and the child(ren) has been removed from that unsafe situation. At shelter care, after hearing the state's petition and the testimony of the DCFS investigator, the judge rules whether or not there is immediate and urgent necessity to place the child(ren) in the temporary custody of DCFS to assure their safety. The CASA Volunteer Coordinator attends the hearing, learns details of the case, observes the parents or caregivers, and begins to think about which volunteer will be best suited for the case. It is possible for a volunteer to be involved within a couple weeks of case opening. It has been proven that a CASA assigned to a case results in permanency being achieved more quickly than if no CASA is assigned. Furthermore, statistics show that involving all parties in the case (parents, attorneys, social workers, foster parents and CASA) at case opening, provides a setting for a better working relationship and a good foundation on which to move the case forward.
