The National Court Appointed Special Advocate Association has issued the following:

Statement Regarding Separation of Children and Parents During the Immigration Process

June 20, 2018

For nearly 40 years the National Court Appointed Special Advocate Association (National CASA) has advocated for the best interests of children who have experienced abuse or neglect. One of our guiding principles is that children are better off when they remain with their families of origin if safely possible.

We also know the long-term effects of trauma that children experience when they are separated from their parents, which are most often detrimental to their well-being and can have long-term negative impact.

While CASA programs and volunteers work in family or juvenile court systems, not the federal court system, we support best-interest advocacy for all children. We have been deeply concerned about the family separations at the Southwest border and thank those who have spoken out on behalf of these children. We join with these voices.

If children involved in immigration proceedings become involved in family or juvenile court, we urge the appointment of a CASA/GAL volunteer to advocate for the child's best interest and help the court make the most well-informed decision in these tremendously important matters.

We ask our nation's legislators to carefully consider the impacts on children when they address immigration legislation so that no child is subjected to further trauma. (taken from casaforchildren.org)





CASA Field Trip! Visit to Mary Davis Home, the Juvenile Detention Center for The 9th Judicial Circuit Galesburg, Illinois

On June 12th CASA volunteers had the opportunity to tour the Mary Davis Home in Galesburg. From left to right, CASA volunteers Margarita Obregon, Jan Greenwood, Diane Banach, Eunice Lutz, Volunteer Coordinator Vicki Duba, and CASA volunteer Brenda Thompson toured the facility which houses juvenile delinquents while a more permanent placement is found. The facility can accommodate just over 30 clients but rarely reaches it maximum capacity. Juvenile delinquent from counties outside of the 9th Judicial Circuit can place juvenile delinquents at Mary Davis if the facility is not at capacity. Several CASA cases are dual cases. abuse and neglect as well as juvenile delinquency.

Following the tour, we enjoyed lunch in the beautiful courtyard of the Landmark in Galesburg. It was a perfect location and allowed time for sharing.
