# COURT APPOINTED SPECIAL ADVOCATE McDonough County, Illinois March 2017 Newsletter

Advocacy Network for Children Mission Statement: To protect and uphold the rights of children when wrongs have been committed against them; to help abused or neglected children have safe, permanent homes where they can thrive; to act as a powerful voice in these children's best interest and to educate the public about the plight of unrepresented children within the child welfare system.

### **Adoption Surrenders and Consents**

A **Final and Irrevocable Surrender for Purposes of Adoption** acts to terminate a parent's rights as soon as the document has been signed. It authorizes/designates DCFS or the adoption agency as the legal parent of the child. Even if the child is never subsequently adopted, parental rights remain terminated.

A Final and Irrevocable Consent to Adoption by a Specified Person or Persons provides a birth parent with the ability to consent to have a particular person adopt his/her child.

Some changes in the law effective January 1, 2013:

- Consents will no longer be "voidable" after the one-year point;
- Parents will provide more detailed contact information to DCFS;
- Caseworker will be required to contact parent if the adoption isn't able to go forward;
- The 6-month waiting period can be waived by the court so parents can sign consents earlier;
- DCFS will provide a "Rights and Responsibilities" form for birth parents.

These things are true under the old law and will continue to be true with the new law:

- Specific consents do not terminate a parent's rights;
- If the adoption isn't finalized, TPR (Termination of Parental Rights) does not occur;
- If the juvenile court issues a TPR order based on a specific/designated consent, the TPR order is only valid as long as the consent is valid;
- The consent is only valid as to the named adoptive parent(s);
- If the child is removed from that placement, the consent becomes invalid and the birth parent's rights remain intact;
- Specific/designated consents do not expire or convert to a general consent one year after being signed; and
- Consents that were signed before January 1, 2013 will be valid according to the old law.

Criteria must be met before a case is appropriate for a specific/directed consent.

- There must be a pending Juvenile Court case;
- The child must have been in the home of the named caregiver/adoptive parent for at least six-months prior to signing the consent unless the court has waived this waiting period;
- DCFS must be in agreement that the caregiver/placement is an appropriate adoptive home;
- Infants under age one have to be in the adoptive home for three months;
- With sibling groups, only one child has to have been in the home for the minimum period of time.

#### **Adoption Surrenders and Consents**, Continued

- Parents should have benefit of legal counsel before signing a consent or surrender;
- Be sure the parent is competent to sign a consent (consider mental health issues, developmentally delayed, English is the preferred language, whether under the influence of alcohol/drugs);
- If parent is mentally ill and/or developmentally delayed, a doctor's statement is needed regarding competence;
- If parent has an adult guardian, the Court can take a specific consent from both the birth parent and guardian;
- DCFS should provide consent or surrender forms to parents in their preferred language.
