April: Child Abuse Awareness and Prevention Month

One of the Advocacy Network for Children's goals is to raise awareness about child abuse. Often the enormity of the problem is just not understood, and some want to believe it "doesn't happen in my hometown." The information presented here contains data from the 27th Maltreatment Report prepared by the Children's Bureau (Administration on Children, Youth and Families, Administration for Children and Families) of the U.S. Department of Health and Human Services. The reporting year (2016) was October 1, 2015 through September 30, 2016. The data gathered was submitted voluntarily by the 50 states, District of Columbia and the Commonwealth of Puerto Rico. The statistics will most likely shock you!

Some child abuse statistics:

- Professionals (daycare providers, educators, legal and law enforcement, medical personnel) submitted 64.9% of suspected child abuse "hotlines" or reports.
- There are a variety of possible outcomes for each report. If the investigation reveals the allegations are supported by state law or policy, the report is *substantiated*. At the other end of the spectrum, the case might be closed because DCFS (Department of Children and Family Services) could not even locate the victim.
- In 2016 there were an estimated 676,000 victims of abuse and neglect.
- Those 676,000 victims represent a 3% increase over 2012.

- 28.5% of those victims were younger than 3 years old.
- Victimization was highest for children under one year old.
- Whether the child was male or female was not significant.
- Caucasian children represented 44.9% of those abused.
- Hispanic children represented 22% of those abused.
- 20.7% of abused children were African American.
- 74.8% of victims were neglected.
- 18.2% of victimized children suffered from physical abuse.
- 8.5% of the victims were sexually abused.
- The four-top caregiver risk-factors contributing to child abuse: alcohol abuse, drug abuse, financial problems and inadequate housing.
- In 2016, 91.4% of abused children were victimized by one or both parents.
- In 2016, an estimated 1,750 children died from abuse and neglect. That represents a 7.4% increase from 2012.
- 70% of those were younger than 3 years old
- Children under 1 year died from abuse and neglect at 3 times the rate of children who were 1 year old.
- Nearly 30% of the fatalities in this study had at least one prior DCFS (Department of Children and Family Services) contact in the 3 years prior to the death.

Prevention. There are some funding streams for prevention services provided to parents whose children are at risk for abuse. These services are designed to provide parents/caregivers education on childhood developmental stages and other types of assistance.

Title I of the Child Abuse Prevention and Treatment Act (CAPTA), as amended [P.L.100-294]— The Grants to States for Child Abuse or Neglect Prevention and Treatment Programs (State Grant) provides funds to states to improve CPS systems. The grant serves as a catalyst to assist states with screening and investigating child abuse and neglect reports, creating and improving the use of multidisciplinary teams to enhance investigations, improving risk and safety assessment protocols, training CPS workers and mandated reporters, and improving services to infants with life

Title II of CAPTA, as amended [P.L. 100-294]—The Community-Based Grants for the Prevention of Child Abuse and Neglect program (formerly the Community-Based Family Resource and Support program) provides funding to a lead state agency (designated by the governor) to develop, operate, expand, and enhance community-based, prevention-focused programs and activities designed to strengthen and support families to prevent child abuse and neglect.

Title IV-B, Subpart 2, as amended [42.U.S.C. 629 et seq.] Promoting Safe and Stable Families— The goal of this legislation is to keep families together by funding such services as prevention intervention so that children do not have to be removed from their homes, services to develop alternative placements if children cannot remain safely in the home, and family reunification services to enable children to return to their homes, if appropriate.

Title XX of the Social Security Act, [42. U.S.C. 1397 et seq.], Social Services Block Grant (SSBG)— Under this grant, states may use funds for such prevention services as child daycare, child protective services, information and referral, counseling, and foster care, as well as other services that meet the goal of preventing or remedying neglect, abuse, or exploitation of children.
