2nd Annual Run for CASA's Kids Raises Over \$8,000 for Advocacy!



Over 50 runners and walkers met at the Old Dairy on Saturday, April 14, to support CASA of McDonough County. The rain held off as 5K participants headed south on Lafayette, looped through the Compton Park area and returned to the Old Dairy via Washington Street. There was also a one-mile family run/walk.

Runner and walker participation was not all that flourished in this year's Run. Volunteer participation grew significantly and insured the event went smoothly. The Morning Rotary of Macomb took the Run for CASA's Kids as a project and supplied nine members to work the registration process and to direct runners along the course. The Macomb City Police Explorers assisted at major intersections along the route to keep runners and walkers safe. CASA volunteers and Friends of CASA also helped make the event a success. Vicki Duba, Volunteer Coordinator for CASA and Beci Steelman, Friend of CASA, co-chaired the event for the second year. They report sponsorships and donations far exceeded their expectations. Steelman says she has "some new ideas for the 2019 event and can't wait to start planning!"

The profit from the event helps assure CASA volunteers can continue their advocacy for abused and neglected children in the juvenile court system through no fault of their own. CASA volunteers speak in the best interest of abused children who most often have been removed from an unsafe home situation of a parent and placed in foster care. It has been proven that having a CASA volunteer assigned to a case reduces the time the case remains open by about 8 months, a significant savings to the county.

The 2nd Annual Run for CASA's Kids is the last in a series of events hosted by CASA of McDonough County, a program of Advocacy Network for Children, in honor of April's Child Abuse Awareness and Prevention Month. Earlier in the month there was a **flag raising** at City Hall where the Awareness and Prevention flag continues to fly for the month of April. Duba, Judge Heidi Benson and CASA Volunteer Eunice Lutz presented **assemblies for Macomb Junior and Senior High students** on child abuse and what students should do if they, or someone they know, are victims of abuse. Blue and silver pinwheels, the symbol of child abuse prevention, have been placed at all schools in Macomb. CASA volunteers and Friends of CASA collected **"Koins for Kids"** at Farm King and HyVee April 7th and raised more than \$600 which will help offset the operating expenses of the program.
