CASA REPORTS MUST INCLUDE AN EDUCATIONAL COMPONET

One requirement of the United Way CASA grant is an educational component be included in the program. CASA volunteers with school age children are required to receive monthly school updates on how the children are progressing academically and socially. They accomplish this by visiting with teachers, administrators and counselors. Volunteers are encouraged to visit pre-schools as well. This information is then shared in the CASA court report.

This is just another way CASA volunteers provide useful information to the Judge and other parties of the court to aid in decision-making.

Volunteers, there will be plenty of time for questions and answers during the workshop. However, if you have a list of questions beforehand, please feel free to submit them and they will be presented to Kirsten prior to the workshop.

Volunteers, please plan to attend this important meeting! You will gain a better understanding of the responsibilities of the agencies who serve not only the abused and neglected children in the juvenile court system but the entire family. This will cover from case inception to case closure. (3 hours of continuing education credit)
