## NEW TRAUMA SUPPORT GROUP TO BEGIN

Advocacy Network for Children is proud to announce it will be funding a new trauma support group. The support group, set to begin on November 12th in Quincy, is for children who have experienced trauma such as sexual abuse, physical abuse or have been a witness to violent crime, and their caregivers.

The goal of the program is to provide support and treatment to help these children and caregivers heal from the pain and mend the effects caused by the trauma. In addition, the program will deal with how to reduce the stigma that comes with abuse services, gain support and build coping skills for these children and caregivers.

The program is for children ages 8 to 18. Separate meetings will be held for their caregivers. Meetings will be held once a week for six weeks and last 90 minutes. After six weeks, program participants will meet once a month. Registration is required.
