



MANDATED REPORTER TRAININGS

Advocacy Network for Children provides mandated reporter trainings at no charge for individuals directly involved with children. Mandated Reporters include medical personnel, school personnel, social service/mental health personnel, law enforcement personnel, coroner/medical examiner personnel, child care personnel, and members of the clergy.

Mandated Reporters are required to report suspected child maltreatment immediately when there is "reasonable cause to believe" that a child known to them in their professional or official capacity may be abused or neglected. Mandated Reporters are required by law to report to one of the following: Department of Children and Family Services, local police department or sheriff's department.

GOVERNOR SIGNS LAW REMOVING SEX CRIME STATUTES OF LIMITATION

On August 11th, Governor Bruce Rauner signed legislation that removed the statutes of limitation for sexual abuse crimes. Statutes of limitations restrict the time when authorities can charge someone after a crime occurs. Senate Bill 189 removes those limitations for felony criminal sexual abuse and sex crimes against children. Under previous law, victims had to report crimes within 20 years after they turned 18. The legislation goes into effect immediately.
