YOU MADE A DIFFERENCE!

We would like to thank everyone who has supported our agency this past year. Your support allowed us to continue helping abused and neglected children in our community.

Between July 1, 2017 and June 30, 2018, our CASA volunteers were a voice for over 200 children in the court system because of abuse or neglect. Our Children's Advocacy Center program coordinated nearly 450 cases of reported sexual abuse or severe physical abuse in the nine (9) area counties served. Crisis intervention counseling is offered to any victim and their non-offending family member that come through one of our Children's Advocacy Centers.

Our Prevention Program made presentations to over 3500 students in Pre-K through 5th grade to teach these students about personal safety, how to respond to unwelcome touches and who to tell if someone gives them an unwelcome touch.

Together, we brought hope, promise, and healing to the most vulnerable victims of a crime, our children.

HOLIDAY GIFT WRAPPING


