CHILD ABUSE AWARENESS AND PREVENTION MONTH

April is National Child Abuse Awareness and Prevention Month. Due to COVID-19 concerns, several community events planned have been cancelled. We will be doing the following **non-communal events** to remember child victims:

- April 1: Pike County CASA staff will be planting pinwheels on the courthouse lawn in Pittsfield to honor the number of abused or neglected children in the county;
- April 6: Hancock County CASA staff will be planting pinwheels on the courthouse lawn in Carthage to honor the number of abused or neglected children in the county;
- April 15: Morgan County CASA staff will be planting pinwheels on the square in Jacksonville to honor the number of abused or neglected children in the county;
- The agency office in Quincy will have a pinwheel display in the front of the office during the month to honor all children who have been abused and neglected.

Regardless of whether events are held, communities need to rededicate themselves to being supportive of families, and play an active role in preventing child abuse and neglect. In addition, we all need to take positive action to promote child and family well-being.



AGENCY RESPONSE TO COVID-19

Amid all the concerns over COVID-19, our agency is taking steps to keep our staff, volunteers and clients safe. Most staff are doing a work from home and can be reached via email or on their cell phones. Our Executive Assistant, Diane Pieper, is working in the office and can assist anyone with questions or concerns.

Our Children's Advocacy Center staff is doing essential forensic interviews only. These interviews are being done on a case-by-case basis and through communication with our multidisciplinary team members. Staff is doing follow-up contact with clients to check on their well-being. Mental health providers are willing to provide mental health services to our clients via telemental health.

Our CASA staff is constantly in touch with its volunteers for assistance and guidance as it relates to child visits via technology and help with case reports. No home visits are being done for the safety of all parties. All informational meetings and trainings have been cancelled or on hold until further notice.

We are following guidelines put into place by our various grantors (both state and federal), the CDC and local and state officials.

We need to all work together to reduce the spread of this virus. At the same time, with all the stress and uncertainty this is causing families, we fear child abuse cases will go up in the coming months. With school and daycares being closed, reporting of child abuse cases are likely to decline. If you suspect a child is being abused, please call the Child Abuse Hotline at 1-800-252-2873.
