



## ***WHAT SHOULD YOU DO IF A CHILD DISCLOSES ABUSE***

If a child tells you that he/she was abused, you should:

- > Avoid denial and keep calm to avoid the child shutting down;
- > Listen and let the child tell his/or her own story;
- > Don't interrogate or ask leading questions as this may confuse the child and hinder any criminal investigation;
- > Reassure the child that he/she did nothing wrong and that it is not the child's fault;
- > Thank the child for telling you and be supportive;
- > Do not contact the alleged perpetrator as this may allow him/her time to prepare a response;
- > Call your local law enforcement or Department of Children and Family Services hotline.

During this unsettling time we are experiencing, children are at a greater risk of being abused. Your call could save a child's life.

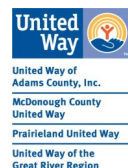

## *AGENCY RESPONSE TO COVID-19*

Amid the concerns over COVID-19, our agency continues to take steps to keep our staff, volunteers and clients safe. Most staff continue to work from home and can be reached via email or on their cell phones. Our Executive Assistant, Diane Pieper, is working in the office and can assist anyone with questions or concerns.

Our Children's Advocacy Center staff are doing essential forensic interviews. These interviews are being done on a case-by-case basis and through communication with our multidisciplinary team members. Staff is doing follow-up contact with clients to check on their well-being. Mental health providers are willing to provide mental health services to our clients via telemental health.

Our CASA staff is constantly in touch with its volunteers for assistance and guidance as it relates to child visits via technology and help with case reports. No home visits are being done for the safety of all parties. Our recent CASA trainings in Adams County and Morgan County were changed to a web-based on-line training. Court observations are currently on hold. Swearing in ceremonies of new volunteers is decided by the Circuit Court of the respective county.

We are following guidelines put into place by our various grantors (both state and federal), the CDC and local and state officials.

We need to all work together to reduce the spread of this virus. At the same time, with all the stress and uncertainty this is causing families, we fear child abuse cases will go up in the coming months. With school and daycares being closed, reporting of child abuse cases are likely to decline. If you suspect a child is being abused, please call the Child Abuse Hotline at 1-800-252-2873.
