30 YEARS OF SERVICE TO ABUSED AND NEGLECTED CHILDREN

This year marks the 30th anniversary of our agency. We opened our doors in January 1990 as CASA of Adams County. The CASA program uses trained community volunteers who then become the voice for a child in the court system. We have expanded the CASA program over the years and now serve children in Brown, Cass, Hancock, Morgan, Pike and Schuyler counties.

In 1999, we opened our first Children’s Advocacy Center in Adams County to serve child victims of sexual or severe physical abuse. Since then, we have added centers in Brown, Cass, Schuyler, Pike, Morgan, Scott, Hancock and McDonough counties.

We also offer and provide a prevention program to children Pre-K through 5th grade. Happy Bear and “P.S. It’s My Body” teaches children safety strategies and is designed to decrease children’s risk of being abused.

Our mission remains to serve abused and neglected children in our community.

WHAT IS FORENSIC INTERVIEWING?

Forensic interviewing is a first step in most child protective services (CPS) investigations, one in which a trained professional interviews a child to find out if he or she has been abused or neglected.

In addition to determining whether abuse or neglect has occurred, this approach produces evidence that will stand up in court if the investigation leads to criminal prosecution. Properly conducted forensic interviews are legally sound in part because they ensure the interviewer's objectivity, employ non-leading techniques, and emphasize careful documentation of the interview.

We are proud to say that our agency has 5 trained forensic interviewers. In addition to our Director of Forensic Interviewing, Jessica Bolton, trained staff include Susan Tode, Todd Shackelford, Jamie Carroll and Karolina Anton. Each has been accredited with numerous hours of continuing education on forensic interviewing. To date, they have conducted nearly 1,150 forensic interviews of children.

HELPING CHILDREN COPE DURING A CRISIS

The COVID-19 pandemic has affected all of us. Each person handles stressful situations differently and children are no exception. Although young children may not fully understand what is currently happening in the world, they know and sense the stress and uncertainty around them. Children's reactions can include: fear of being alone, change in appetite, experiencing bad dreams, becoming withdrawn from family or friends, increased irritability, whining or aggressive behavior. If you notice a change in a child, patience, tolerance and reassurance are key. If changes in behavior or mood persist, don't be afraid to seek the help of a mental health professional.

AGENCY RESPONSE TO COVID-19

Amid the ongoing concerns over COVID-19, our agency continues to take steps to keep our staff, volunteers and clients safe. Staff will be returning to the office in shifts starting June 1st with changes put in place. Walls and plexiglass have been added to our Executive Assistant's front office area, shared staff offices have been separated with a new office added to our lower level.

Our Children's Advocacy Center staff continue to do essential forensic interviews. These interviews are being done on a case-by-case basis and through communication with our multidisciplinary team members. Staff is doing follow-up contact with clients to check on their well-being. Mental health providers remain willing to provide mental health services to our clients via telemental health.

Our CASA staff is constantly in touch with its volunteers for assistance and guidance as it relates to child visits via technology and help with case reports. No home visits are being done for the safety of all parties. Required contact is being arranged with everyone's safety in mind. Attendance at juvenile court case hearings are being done at the direction of the respective county.

We are following all guidelines put into place by our various grantors (both state and federal), the CDC and local and state officials.

We need to continue to all work together to reduce the spread of this virus. At the same time, with all the stress and uncertainty this pandemic is causing families, we fear child abuse cases will go up in the coming months. With schools and day-cares being closed the last few months, reporting of child abuse cases has declined significantly.
